SANParks Regulations

The National Environmental Management: Protected Areas Act (Act no. 57 of 2003) and the Regulations promulgated in terms thereof, determines that it is an OFFENCE to:

Regulation (Penalty)

- 4(1)(d) Feeding of any species or specimen. (R400)
- 4(1)(c) Intentional disturbance of any species (R500)
- 4(1)(g) Cut, damage, destroy or be in possession of any plant or part thereof, including dry wood or firewood. (Court)
- 12 Entering or taking a vehicle in a national park onto a road in an unsafe, reckless or negligent manner. (R300)
- 14 Enter, leave or travel at any time other than the times determined by the management authority. (Varying)
- 16(1)(a) Driving a vehicle in a manner that constitutes a nuisance, disturbance, inconvenience or danger to any other person. (R500)
- 16(1)(d) Drive or park anywhere except on a designated road. (R500)
- 16(1)(f) Drive or operate any vehicle in a reckless or negligent manner or in a deliberate disregard for the safety of a person, animal or property. (Court)
- 40(a) Deposit or leave any litter except in receptacle for that purpose. (R300)
- 43(e) Light or cause any fire to be started or make use of an open fire other than in a fireplace or container made available. (R500)
- 43(m) Play any radio, compact disc player, music system, musical system or instrument, or in any way cause any noise in any manner likely to disturb any species or specimen or other person. (R500)
- 43(n) Behave in an offensive, improper, indecent or disorderly manner. (R500)
- 44(1)(a) Convey or be in possession of any firearm or dangerous weapon, explosive, trap or poison. (Court)
- 45(2)(b)(i) Import into a national park any specimen of an alien or listed invasive species. (Court)
- 49(1) Bring dog, cat or pet into a National Park. (R750)
- 62(a) Hinders, troubles, intimidates or obstructs an authorized official in the execution of his duties or the performance of his functions. (R750)
- 62(b) Violates, refuses or fails to obey or comply with any prohibition, request or instruction imposed by these regulations or by the management authority or authorized official. (R500)
- 62(b) Violates, refuses to obey or comply with any prohibition, request or instruction by alighting from a vehicle or protruding from an open door or roof. (R500)

To abide by the speed limit of 50km/h (varying)
